Dear Colleagues

Although the activities of the Local Safeguarding Children Board (LSCB) may seem rather remote from the front line, the Redbridge Board is a really strong focus for partnership working in the borough to safeguard and promote children's welfare.

I have been chairing the Board since August 2014. During this time we have put new arrangements in place to make sure that across agencies we are effectively identifying and protecting young people at risk of sexual exploitation, and have developed much more joined up working to help disrupt and prosecute the activities of perpetrators.

We have launched a programme of multi-agency audits of practice, both to identify strengths and to highlight areas improvement, and through a programme of constructive challenge we have strengthened the accountability of all partner agencies to each other and to the Board. We have continued to deliver a very extensive training programme, and I do urge you to have a look at the programme on the LSCB website to identify the training opportunities that might be helpful to you and your practice. This year I am keen to do more to learn from the experience of front line practitioners in all agencies - health, education, police, the voluntary sector, and others - about how we can improve safeguarding in Redbridge. For example, at the moment reviewing the threshold are document, which sets out a framework for describing the different levels of need which families and children who need support might have, and when it is appropriate for social care to become involved. I am hoping to meet as many front line staff from across partner agencies as possible at the 'Meet the Chair' events in February (see page 3 for further information).

I know we also need to listen to and learn from young people themselves more. That's why our annual conference on 26 April will be organised around professionals listening to young people on what they think the most important safeguarding issues are, and thinking about how as adult professionals we can work with them better to help them feel and be safe. More about this on page 3 tool

I think this is an exciting and challenging time to be involved with the work of the LSCB, and I hope you will take up some of these opportunities. In the meantime, my very best wishes for 2016.

LSCB Priorities 2015/2016

The LSCB set out its priorities for the year in its annual <u>Business Plan</u>. In 2015—2016 we have six key priorities. These are:

Priority 1: To improve the protection and support of children who are sexually exploited, and to strengthen our work in identifying, disrupting and prosecuting child sexual exploitation.

Priority 2: To improve the protection

Priority 2: To improve the protection and support of children living with domestic violence, substance abuse, and adult mental health. **Priority 3:** To improve the protection of young people from involvement with violent extremism.

Priority 4: To strengthen the safeguarding of children with disabilities, and to reduce the incidence of disability by increasing awareness of the risks of consanguineous relationships.

Priority 5: To strengthen our work in preventing, identifying and protecting children from neglect.

Priority 6: To increase the effectiveness of the LSCB in co-ordinating and ensuring the effectiveness of the work of all agencies to safeguard and promote the welfare of children and young people.

Against each priority, the Plan sets out what we will do, who is responsible, when actions will be completed by, and how we will know if it has improved the lives of children and young people. The board reviews progress against the Plan at every meeting.

Female Genital Mutilation

Female Genital Mutilation (FGM) is increasing featured in the media, particularly since the Government implemented the mandatory requirement to report from 31 October 2015.

FGM is the partial or total removal of external female genitalia for non-medical reasons. It is also known as female circumcision or cutting.

If this is a subject that you are not familiar with, it is important that you understand the facts and your duty to respond. The LSCB website includes some useful information, including links to various resources that you may find useful plus a Home Office free elearning module, a factsheet

and guidance for professionals.

Key points to remember are:

- FGM is child abuse;
- FGM affects girls and women in the UK; (current estimate 137,000 although the true extent is unknown due to the "hidden" nature of the crime);
- FGM is illegal in the UK;
- FGM can have a very negative effect on health and wellbeing;
- FGM can kill!
- You have a legal duty to report known cases of FGM carried out on a child under 18 to the police. If you become aware of a case.

the duty to report is yours personally, and you can't delegate it to your manager or anybody else.

Somebody Else's Child - Everybody's Responsibility



Please help us to ensure the safety and well-being of children in Redbridge who are being cared for by someone who is not a direct relative.

Private Fostering describes arrangement when someone who is not a close relative cares for another person's child for 28 days or more. A close relative is defined as step-parent, grandparent, brother, sister, uncle or aunt. A child is defined as under 16 years old, or under 18 if disabled. Although this is undertaken as a private arrangement, legally the parent and the carer must notify the local authority where the child is going to live so that the local authority can ensure that the child is being properly looked after. In order to promote the safety of children ,it is important to ensure that the Private

Fostering arrangements for children who are living away from their parents are suitable. Serious case reviews (SCRs) such as the case of Victoria Climbié highlight the importance of monitoring these arrangements to ensure that children are safeguarded. Nobody knows exactly how many children are privately fostered, and it is feared that many of these 'invisible' children could be at risk of abuse, or victims of trafficking. We are aware of a number of private fostering arrangements in Redbridge but we believe there are many more that we are unaware of as some families may not know that there is a duty to inform Authority of such Local arrangements. We need the help of people working with children to be

aware of private fostering and to notify immediately if they suspect such an arrangement. Teachers, early years and health staff are particularly well placed to identify cases of private fostering. Information sharing is vital to safeguarding and promoting welfare of children and young people and it is essential to enable early intervention and preventative work. Lessons from Serious Case Reviews (SCRs)

The NSPCC maintain a national <u>Case Review Repository</u>, which was launched in collaboration with the Association of Independent LSCB Chairs in November 2013. The repository provides a single place for published case reviews to make it easier to access via a helpful <u>search</u> facility and share learning at a local, regional and national level. The



repository is accessible via the NSPCC library online and contains over 600 case reviews and inquiries dating back to 1945. The NSPCC have also provided a number of thematic briefings and review of Learning from SCRs based on types of abuse; professional practice; and specific sectors.
