Foreword from the Independent Chair of the RSCP

Welcome to the Autumn 2020/21 edition of the RSCP newsletter. The last full meeting of the Partnership took place on MS Teams on 8 October, and a summary of some of the items discussed can be found on the next page.

Inevitably, the ongoing impact of the pandemic was again a major focus of discussion. There are ongoing impacts: levels of mental health presentations by young people at A&E, the impact on families of poverty and parental ill health, the impact on staff morale of isolation from colleagues. Prepandemic issues are resurfacing, and some new issues arising. The number of missing episodes is going up; hospital colleagues report a 30-50% increase in children and young people presenting at A&E, and an increased number of children and babies being admitted; the police report an increase in child abuse investigation referrals and referrals for child sexual abuse. Schools are seeing increased anxiety levels among young pressurised by bombardment on social media of antivaccination propaganda. Face to face services are resuming, but, for example, child protection case conferences continue to be held online. This has a very positive impact on professional attendance, but there are negative impacts for some families and young people trying to deal with an array of professionals in small onscreen boxes. There is a key judgement to be made as we finally emerge from the pandemic about the right model for the future.

Locally and nationally, there has been a massive increase in domestic abuse during the pandemic. The Board received a report on the incidence of and response to domestic abuse in the borough, based on a review by SafeLives carried out over more than a year from February 2020. Even though this is recognised as a massively important and prevalent issue by all local agencies, the review nevertheless found that there is very significant under-reporting to the police and other services. Perhaps most shocking was some of the professional attitudes reported to the researchers. 43% of professionals in Redbridge surveyed thought that victims and perpetrators were 'as bad as one another'. 36% believe it is the victim's responsibility to protect children. 18% believe that there are a lot of malicious reports of domestic abuse. We have no room for complacency.

One of the key first steps in safeguarding and promoting the welfare of children who come into care is ensuring that they benefit from an initial health assessment within the first 28 days. In spite of all the pressures of the pandemic, the Board was to see а dramatic delighted improvement in this performance measure - up from 52% in 2020/21 to 81% in the first quarter of 2021/22. This has been achieved through unremitting hard work between NELFT, the CCG, and children's social care, championed in particular by Sue Nichols, Designated Nurse at the CCG, who was attending her last RSCP meeting before retiring. The Board paid tribute to her dedication over the years to partnership working and her passionate commitment to the welfare of vulnerable children.

Almost finally, I would like to use this Foreword to encourage everybody involved with safeguarding children to find time to read the recent report from the Child Safeguarding Practice Review Panel, The Myth of Invisible Men: Safeguarding Children under One from Non-Accidental Injury by Male Carers. It paints a very challenging picture of the systematic though unwitting exclusion of male partners from the safeguarding process in both specialist and universal services, sometimes with tragic consequences. "The involvement of men is no more evident in key statutory children's services, particularly children's social care, than it is in universal services. Men are only partially seen (if that) and insufficient regard is given to working effectively and creatively with them. This compounds the ability of some men to evade responsibility and scrutiny from professionals for the risks they present to their children". Research has found that fathers are only invited to child protection case conferences 55% of the time, that known violent fathers are not contacted by social workers prior to meetings 38% of the time, and that only 68% of completed assessments

included contact with the father. In

Redbridge as everywhere else, we need to challenge ourselves as to whether our own practice reflects these findings.

And finally...this is the last RSCP Newsletter to which I shall write the Foreword. I have made the difficult decision to stand down from chairing both the RSCP and the Safeguarding Adults Board in January 2022, after seven and a half years, in pursuit of what I now aspire to as a life/life balance. It has been challenging, stimulating and deeply rewarding to work with so many colleagues in the Redbridge partnerships with such a strong commitment to working together to safeguard, empower and enhance the life chances of vulnerable children and adults. I wish you all the very best for the future – and in the shorter term, I wish you all a very happy Christmas.

Board Report Feedback from the RSCP Meeting – 8 October 2021

Summary of items discussed by the Board

Among other items, the Partnership:

- Received safeguarding performance data for the period April to June 2021, with some verbal updates from partner agencies. The overall picture was that, while the expected surge in referrals to children's social care, following the loosening of pandemic restrictions, had not materialised, there has been a reported increase in the complexity of needs presented. Fewer referrals are leading to a S47 enquiry, but more of those enquiries are leading to an initial child protection case conference than in previous periods. The data clearly showed the continuing impact of the Covid-19 pandemic and the pressures on services. Fewer care leavers are in education, employment or training; there has been a big increase in waiting times for a CAMHS service from the point of referral.
- Received feedback from partner agencies on the ongoing impact of the pandemic, recovery and resilience. This is further discussed in the **Chair's Foreword**.
- Received and discussed a presentation from Superintendent John Carroll on improvement work going on across the Metropolitan Police Service (MPS) to improve safeguarding outcomes for children. The focus is on developing performance measures which measure quality in terms of victim outcome rather than in terms of efficiency or process completion. The initial concentration has been on developing targets for improved performance in a victim-focused approach in the areas of domestic violence, child abuse, rape, and sexual offences. Of the 40 measures so far defined, the East Area BCU is currently meeting targets in eleven of them, although this is in the upper half of performance in the MPS as a whole. An improvement programme has invested in audit activity, which is beginning to demonstrate some improvement in practice, albeit from a very low base. The Partnership welcomed a very open presentation and is keen at a future meeting to explore particular areas in more detail.
- Received a presentation on Baby and Me, a new programme launched recently in children's social care. The number of babies coming into care has been going up significantly. The programme aims to target assessment and support at an earlier stage of pregnancy, to engage more consistently with the fathers of unborn children, and to expand the use of Family Group Conferences.
- Received a report on Redbridge's performance in providing alternative full-time education for young people permanently excluded from school a key issue in reducing young people's vulnerability to criminal exploitation. Redbridge performs strongly, with the great majority of excluded young people back in education within six days.
- Received a presentation on the review of domestic abuse services in Redbridge undertaken by SafeLives in 2020/21 and the multi-agency action plan that has been developed in response. This is discussed further in the **Chair's Foreword**.
- Considered a report from the North Central and East London CAMHS Provider Collaborative on the work they have done to improve the management of and access to Tier 4 (specialist inpatient) beds for young people with acute mental health problems. The RSCP has been concerned for some time about the impact on very distressed young people of very long waits in A&E while attempts are made to find an appropriate and local bed. The Board was pleased to learn that in the first year of the programme, admissions to Tier 4 beds had reduced by 34%, out of area placements were down by 73%, admissions for children living with autistic spectrum conditions were down by 50%, and average length of stay had been reduced by 43%. It noted, however, that out of hours response and provision remained problematic.

RSCP Safeguarding Priorities 2020 - 2021

Priority 1

Safeguarding Adolescents

Completing the work begun in 2019/20 on transitional safeguarding – a joint project with the <u>Redbridge Safeguarding Adults Board (RSAB)</u> to develop proposals for an effective Redbridge response to the needs of young adults at risk of exploitation, recognising that adolescence as a developmental phase does not suddenly end on the eighteenth birthday. **A further planning meeting has been arranged between Redbridge Children's Social Care** and Adult Social Care representatives in September.

Carrying out a multi-agency self-assessment against the questions and challenges posed in <u>"It was hard to escape: safeguarding children at risk from criminal exploitation", a thematic review published by the Child Safeguarding Practice Review (CSPR) Panel. The 'four key areas' are problem identification, supporting your staff, service design and practice development, and quality assurance. A report based on this self-assessment was presented to the July Partnership meeting.</u>

The London Safeguarding Children Partnership (LSCP) nine principles for safeguarding adolescents to be embedded in the above work streams and across agencies in the Partnership (see page 2 of the RSCP Plan and Priorities 2020 – 2021).

Priority 3

Child sexual abuse in the family environment

The Joint Targeted Area Inspection (JTAI) Report on the multi-agency response to sexual abuse in the family environment, published in February 2020, identifies nine challenging findings which are highly critical of much practice in this area. The Partnership carried out a 'true for Redbridge?' multi-agency self-assessment against these key findings. A report on this was presented to the July Partnership meeting.

Priority 2

Monitoring and supporting the multi-agency safeguarding response to the COVID-19 pandemic

Continuing to monitor and support the multi-agency safeguarding response to the challenges of the Covid19 pandemic, the safeguarding risks that have been identified in this context, and the management of the recovery phase.
