| Summary Reason for this contact | | <p>Referral to explore support services for the family in respect of father, Harold Potter's mental health and possible impact to family.</p> <p>My client is the children's father (Harold Potter), previously known to out-of-area Mental Health Services and admitted under S2 to Cygnet Hospital in February 2024. They came for medical appt on 7/01/24 and wife stated she is scared her husband could harm his family as he is suspicious of her. He thinks the wife is poisoning him with medication. On 7/01/25 any signs of aggression were denied. However, on 8.01.25 wife contacted the police as Harold pushed her and was not allowing Lucy to get ready for school.</p> <p>During the medical appt. Mr Harold Potter complained that his family were trying to harm him. He could not sleep at night as his wife and his son walked up and down the stairs to disturb him. He claimed to keep watching over his child at night as he was afraid that someone might harm her. He said he had received a telephone call from an unknown person saying "be careful... or else"; he was unsure who would want to harm his children or why. He was convinced that his wife added extra salt and possibly Bangladeshi medicines in his food to make him 'brain damaged'. He accused her of cooking good food for herself but starving their child; he also accused her of feeding them 'sleeping potions' despite his wife's assurance that they were Vitamins.</p> | | | | |

His mental health is clearly deteriorating and a Mental Health Act assessment for the father has been requested.

Wife disclosed that Lucy has a diagnosis of ASD.

Since I am unsure if the social services are already involved, I am sending the referral as I think the family needs to be supported regarding Lucy

Please note that the wife told me that once Harold has been admitted to Hickworth Hospital in February 2024, family was living in Tilbury and social services were involved there.
