Reason for referral						
Summary Reason for this contact		<p>We are making this referral as we are concerned that, without support, Sophia may endanger herself or others or is at risk of harm to herself.</p> <p>This is a referral for either the Children with Disabilities team or the Early Help Team. We have discussed this with Sophia's mother (Daniel Eastwood) who requested this intervention and we include pertinent information gained in Sophia's recent Termly Review and Transition Meeting held at school. (June 2025) This referral is being completed to gain support for the child and family regarding Sophia's disability and current extreme needs. This referral was discussed with Ms Eastwood in a further meeting with our Head teacher where Ms Eastwood wholeheartedly supported a referral to your service through a MARF.</p> <p>Sophia is currently in Reception at our school. She has a diagnosis of Autism and is mostly non-verbal. She does use words to name but not to communicate effectively or in context. Sophia also has a diagnosis of Epilepsy and Ms Eastwood is awaiting further assessments for possible ADHD. Given Sophia's age, this is not yet appropriate. Sophia has an Education, Health and Care Plan in place already and Redbridge SEN Panel recently agreed with our request to enhance Sophia's resourcing due to her extreme needs in school.</p> <p>Ms Eastwood has always maintained that her daughter's behaviour is exceptionally challenging and that she is trying to manage this by herself as a single mother. Sophia's behaviour at home and at school is of significant concern. On a day to day basis Sophia will hit, kick, scream and throw herself off of furniture, break TVs, hurt people walking next to her when she is out; in short mum feels trapped by Sophia's extreme behaviour as she cannot take Sophia anywhere without concern.</p>				

	<p>Since Sophia joined us in Reception, we have employed many strategies with limited success following advice from outreach staff and specialists. We have seen small changes in Sophia's behaviour but, recently, her behaviours have been so significant that staff and children are being hurt daily. One morning, Sophia slapped two members of staff around the face and kicked countless children and other staff. She has also high kicked two members of staff in the neck and head and threw resources at children. These are not isolated incidents. When Sophia is exceptionally dysregulated, she not only endangers others but herself too. She will throw herself off the furniture, smash herself against objects and the floor and smash her hands to windows and doors. She screams so loudly that she makes her throat hoarse. Although we have received bespoke training from a sensory integration OT (provided by school to all staff) and have utilized this and many other strategies we have not yet found a way to calm Sophia sufficiently in order to keep her and those around her safe and happy.</p> <p>For Ms Eastwood, at home, Sophia's behaviour is even more challenging. Sophia has attempted to throw herself down the stairs from a banister, has broken TVs by smashing them, furniture is upturned and broken and Sophia attempts to run out of their house. Ms Sol is at a loss to control this behaviour. She has no respite from Sophia's extreme behaviours and even has to take Sophia to the bathroom with her, as she cannot be left at all without endangering herself.</p> <p>In a recent Review Meeting Ms Eastwood stated that she has now resorted to locking Sophia into a bedroom. This is for Sophia's own safety in Ms Eastwood's opinion. Although Ms Eastwood states that the room is fitted with a camera, minimal furniture, appropriate and calming toys and a low bed, we agreed in a DSL meeting that this extreme measure indicates a need for the social care team to be involved within the family to consider alternative options for keeping Sophia safe.</p> <p>Ms Eastwood expects there to be an assessment of Sophia and the family and she welcomes the opportunity to gain help. She does not want her little girl to keep hurting herself and others and does not know what further measures she can take to protect her daughter, herself, others around her plus her home and property.</p> <p>Sophia has significant special educational needs that are currently managed in a mainstream school. Sophia is mostly non-verbal in the setting but may interact with other children and adults using body language and facial expressions. Sophia cannot manage any self-care independently. She is not toilet trained, remains in nappies, and needs us to help her with feeding. She requires constant vigilance in order to keep her safe in the setting and at home. Sophia's dysregulation has become extremely difficult to manage at home and at school. In both settings we are at a loss as to how to calm Sophia and to try to stop her from hurting and injuring himself and others. She resorts to hitting herself so hard on the floor and furniture that she is marked and bruised. Sophia's frustrations are also projected towards others. Mum and staff struggle to prevent other children being hurt and adults are frequently hurt trying to prevent this.</p> <p>Ms Eastwood is trying to manage her daughter's extreme needs but requires further support from a team who will be able to offer further advice and guidance to her.</p> <p>Ms Eastwood shows love, warmth kindness and care to Sophia but she is exhausted from managing her on her own and is desperate for respite and strategies to manage.</p> <p>At home Mum has got age appropriate toys and games. She strives to keep Sophia and those around her safe but cannot do so.</p>
